- 1. I, V Suresh, a Company Secretary in practice, have been appointed as a scrutinizer by
 - (i) The Board of Directors of the Company for the purpose of scrutinising the Postal Ballot voting process in compliance with the Companies Act, 2013 and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015; and
- 2. The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 read with relevant Rules thereunder and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 relating to Postal Ballot and E- voting, on the resolutions contained in the Postal Ballot Notice pursuant to section 108 &110 of the Companies Act, 2013 and rules thereunder.  - 1. The Company completed the dispatch of postal ballot forms on 22ndFebruary 2019, along with postage prepaid business reply envelope to its Members whose name(s) appeared on the Register of Members/list of beneficiaries as on 15th February 2019.
 - 2. Postal Ballot has been conducted in compliance with the Companies Act, 2013 and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.
 - Particulars of all the postal ballot forms received from the Members have been entered in a register separately maintained for the purpose.



- 4. All the postal ballot forms received upto the close of working hours (5.00 PM) on 25th March, 2019 the last date and time fixed by the company for receipt of the forms, were considered for my scrutiny.
- 5. Postal ballot forms, received after 5.00 P.M. of 25th March 2019 were not considered.
- 6. The Public Advertisement with respect to dispatch of notices and conducting of voting was published in an English Newspaper Business Line (in English) and vernacular newspaper Makkal Kural (in Tamil) having a wide circulation, in their respective editions dated 23.02.2019.
- 7. Postal ballot forms returned undelivered is 227.
- 8. The e-voting period remained open from Sunday, 24thFebruary 2019 (9:00 A.M.) to Monday, 25th March 2019 (5.00 PM).
- 9. The members of the Company as on the "cut-off" date i.e. 15th February 2019 were entitled to vote on the resolutions in the Postal Ballot Notice.
- **10.** The Corporate members have provided the copy of the resolution passed at the Board of Directors for authorisation to exercise their votes.
- **11.** The votes cast were unblocked on 25th March 2019 in the presence of 2 witnesses, who are not in the employment of the Company.
